Youth and Professional Organizations

 One purpose of youth organizations is to help prepare young people for their adult roles in society

■ The purpose of professional organizations is to help promote the career areas in which their members work



Getting Organized

- A *constitution* is the set of laws that govern an organization
- Bylaws are a set of specific rules that expand the constitution by giving more information

Getting Organized

- A constitution includes
 - the name and purpose of the group
 - membership requirements
 - the group's officers, their duties, and the method of election
 - * basic meeting requirements
 - procedures for changing the constitution

Electing Officers

- A group's constitution and bylaws states which officers to elect and their duties
- *Standing* committees are permanent committees
- Ad hoc committees are appointed to perform a specific task



Holding a Meeting

- Parliamentary procedure is following the guidelines used by many organizations to conduct meetings in an orderly manner
 - * Minutes are an official record of what took place at the meeting
 - * A motion is a suggestion to take action
 - To **second** a motion means to show support for it
 - * A *majority* is usually half the total number of members present plus one

Choosing Effective Programs and Activities



- Some people join organizations because they need outlets for their energy and ideas
- The key to keeping members involved is planning good activities

Choosing Effective Programs and Activities

- Following a planning process can help keep members involved in setting group goals
 - Identify concerns
 - Set your goal
 - Form a plan
 - * Act
 - Evaluate

Discuss

- Research has shown that 10% of the members in a typical group do most of the work. About 80% tag along and enjoy being part of the group. The other 10% complain and criticize.
- How would you keep the interest of the 10% who are active?
- How would you motivate 80% of tagalong members to get involved?
- How would you involve the 10% who criticize?

Stay Within the Limits

- Avoid planning activities that are beyond your group's resources
- All groups have limited amounts of
 - * time
 - money
 - participating members

Publicize



- Publicizing your group's activities can
 - generate more participation
 - attract new members to the group
 - build support for your group in the community

Evaluate Your Accomplishments

- Determine how much your group has accomplished toward achieving your goal
- Discuss how the group can improve and become more successful in the future
